Losing the sense of God's kingdom, is losing the sense of sin

"The greatest sin today is that people have lost the sense of sin" and therefore "the meaning of the kingdom of God" and in its place a "supernatural anthropological vision" has emerged according to which "I can do anything." This was the lesson that Pope Francis drew in his homily at Mass this morning at Casa Santa Marta from the biblical episode in which King David falls in love with Bathsheba and sends her husband, general Uriah, to fight in the front line and thus to certain death. It is in fact a murder.

The Pope noted that "David is faced with a great sin, but he does not see it as a sin. He doesn't even think of asking for forgiveness. Instead all he thinks about is: 'How can I resolve this?'".

"This can happen to us all. We are all sinners and we are all tempted and the temptation is our daily bread. If anyone ever said: 'I've never been tempted', either you are a cherub or a bit ' stupid, right? It's understandable ...its part of life's normal struggle, and the devil is never quiet, he wants his victory. But the problem - the most serious problem in this passage - is not so much temptation and sin against the ninth commandment, but David's behavoir. Here, David does not speak about sin, but about a problem that needs solving. This is a sign! When the Kingdom of God is forgotten, when the Kingdom of God diminishes, one of the signs is a loss of the sense of sin".

Every day, reciting the "Our Father", we ask God, "Thy kingdom come ...", which - says Pope Francis - means "that your Kingdom may grow". But when you lose the sense of sin, you also lose the "sense of the Kingdom of God" and in its place - the Pope said - there emerges an "anthropological vision" according to which "I can do anything".

"The power of man instead of God's glory! This is the daily bread. This is why we pray every day to God' Thy kingdom come, Thy kingdom grow ', because salvation will not come from our cunning, our cleverness, our intelligence in doing business. Salvation comes from God's grace and how we train ever day of our Christian life for this grace".

Pope Francis quoted the famous phrase of Pope Pius XII: "The greatest sin today is that men have lost the sense of sin". H then went on to look at Uriah the innocent man put to death because of his king's guilt. Uriah, the Pope says, becomes the emblem of all the victims of our inadmissible pride.

"I confess to you, when I see these injustices, this human pride, even when I see the danger that this will happen to me, the danger of losing the sense of sin, it makes me think of the many good Uriahs down through history, of the many Uriahs who today suffer our Christian mediocrity, when we lose the sense of sin, when we diminish God's kingdom ... These are the unrecognized martyrs of our sins. It would do us well to pray for ourselves today, that the Lord give us the grace to never loose the sense of sin, that His Kingdom is not diminished in us. We should also bring a spiritual flower to the graves of these contemporary Uriahs, who pay the bill for the feast of the secure, of those Christians who feel secure".

Discovering Christ

As we continue to embrace the new parish vision of "Preaching Like Paul, Serving Like Peter, Faithful Like Mary," we have looked around for a small-group experience that will dovetail with this new vision to bring our parishioners to a greater sense of knowing, living, and sharing their faith. We feel like we have found such a program with the ChristLife ministry. ChristLife (www.christlife.org) is lay Catholic ministry, recognized as an apostolate of the Archdiocese of Baltimore, which was begun in 1995.

Beginning February 9, St John Parish will begin the first part of a three part Christlife program. This program offers three 7-week components entitled "Discovering Christ," "Following Christ," and "Sharing Christ." These three components match well with the vision of "Faithful," "Serving," and "Preaching," as put forth in the parish Vision. The program meets on Sunday evenings and begins with a shared meal beginning at 6:00 pm, a large group prayer and learning segment starting at 7:00 pm and small group discussion until 8:30 pm.

I would like the Knights to participate in the process and consider being a small group leader or helper. Chris Deaver estimates that he needs 5-10 facilitators and 5-10 helpers to make the program a success. If you can help in either role, contact Chris at <u>AFF@STEHYDES.ORG</u>.

In the aftermath of the Philippines' Typhoon Haiyan considered the strongest recorded storm ever to make landfall the Knights of Columbus will donate more than \$750,000 to assist in relief efforts. Some \$500,000 of that amount has come from local K of C councils and individuals from throughout North America.

The Nov. 8 typhoon's 195-mile-per-hour winds and 20-foot ocean surges killed more than 6,000 and displaced millions, reducing seaside villages to splintered piles of wood and tearing a gash across the center of the islands from the Pacific Ocean to the South China Sea.

The Knights of Columbus has strong ties to the Philippines, where it has had a presence since 1905 and today counts hundreds of thousands of members, including many who were victimized by the typhoon.

"Both at the height of the storm and in its aftermath, the Knights were there -- first with their prayers, and also as rescuers and relief agents," said Supreme Knight Carl Anderson. "Locally and internationally, we remain committed to helping the people of the Philippines rebuild their lives."



From Acquiescence to Support of Immorality

In the past 50 years, the Supreme Court has systematically and consist-ently ruled to disestablish the legal basis for a moral society. The Court legalized the use of contraception for married couples in 1965, for unmarried persons in 1972, and then made abortion a right in *Roe v. Wade* in January 1973. The judicial instrument for this statutory disassembly was a created "right to privacy," an amorphous concept that has been continually expanded to legalize more and more formerly illicit acts.

The enlargement did not end with *Roe*. In *Planned Parenthood v. Casey*, in 1992, the Court, addressing a woman's right to an abortion, stated: "At the heart of liberty is the right to define one's own concept of existence, of meaning, of the universe, and the mystery of human life." This statement is so all-encompassing and open to interpretation that Judge Robert Bork believed that, if followed, the courts could invalidate all laws regulating individual behavior.

And so it was. The judicial logic was taken to the next step in *Com-passion in Dying v. Washington*, in 1996. If a woman has the right to kill her unborn child, does she not have the right to take her own life? In its majority opinion, the Ninth Circuit Court of Appeals wrote, "every man has the liberty to determine the time and manner of his death," a statement without limitations, such as a person being termi-nally ill. Assisted suicide and euthanasia were given legitimacy.

Then, sodomy laws were challenged. These primarily were state statutes understood by the courts to outlaw any sexual act, typically between persons of the same sex, deemed to be "unnatural" or immor-al. In 1962, every state had laws making sodomy illegal; although soon after individual states began to repeal those bans. If sex is viewed strictly for pleasure with no procreative aspect, there is no reason why it should be limited to persons of the opposite gender. The Supreme Court in 2003, ruling in *Lawrence v. Texas*, followed the trend and invalidated all sodomy laws.

With homosexual acts legalized and the marital act's focus on pleasure, it was natural to redefine the meaning of marriage. In the 1990s, virtually all states statutorily banned same-sex marriages, alt-hough some were moving in the direction of recognition. To limit the movement, Congress passed the Defense of Marriage Act (DOMA) in 1996, which defined marriage solely as a union between a man and a woman for federal purposes. This was to prove a temporary hindrance.

Massachusetts, by a ruling of its Supreme Judicial Court in 2004, le-galized same-sex marriage, making it the first state to do so. DOMA was then assailed. In June 2013, in *United States v. Windsor*, the Su-preme Court ruled that DOMA was unconstitutional as it restricted the interpretation of the terms "marriage" and "spouse" to heterosexual couples. The same day, the Court allowed a lower court decision to stand, which overturned an amendment to the California State Constitution limiting marriage to one man and one woman. Today, 17 states allow same-sex marriage, with Illinois to become the 18th on June 1, 2014; 10 others recognize same-sex unions. These changes have been accomplished through court rulings, legislative changes, or direct pop-ular vote.

The definition of marriage was now open to further dilution. Kody Brown and his four wives, members of a fundamentalist Mormon sect who star in the reality TV show, *Sister Wives*, contended that Utah's law banning polygamy violated their right to privacy and religious freedom. In December 2013, U.S. District Court Judge Clark Wad-doups ruled that the prohibition was unconstitutional. In his ruling, he cited *Lawrence*, in which Supreme Court Justice Anthony Kennedy stated that the Constitution guarantees people "an autonomy of self that includes freedom of thought, belief, expression and certain inti-mate conduct."

A new phase of clreansing the culture of traditional behavioral values has now begun. For 50 years, as the courts have increasingly legit-imized immorality, the public has acquiesced. Now the courts are forcing people to be not only accepting, but supportive of acts that oppose their religious beliefs. Small businesses, such as bakeries and photographers, are being sued for not providing their services to celebrate homosexual marriages, even when those marriages violate the consciences of the business owners. The American Civil Liberties Union has brought suit against the United States Conference of Catho-lic Bishops, claiming that the bishops pro-life health directives pre-vented a Catholic hospital in Michigan from providing a woman with adequate health care, that is, an abortion. Catholic social agencies have been forced to close for not providing adoption services to homo-sexual couples.

The string of rulings legitimizing immoral behavior is endless. Justice Antonin Scalia, dissenting in *Lawrence*, said that morals legis-lation is now constitutionally impermissible. With an end to virtually all legislative constraints on immorality, can the courts continue to rule against incest, pedophilia, bestiality, group marriages, and other erotic fantasies?

Pope Paul VI, in his encyclical, *Humanae Vitae*, published in 1968, described the consequences that would follow the widespread ac-ceptance of contraception. He warned:

Consider also the dangerous weapon that would thus be placed in the hands of those public authorities who have no concern for the requirements of morality... Who will stop rulers from favoring and even imposing upon their peoples, if they should consider it necessary, the method of contra-ception that they judge to be most efficacious?"

How perceptive Pope Paul VI was. Now four-and-a-half decades after he expressed his concern, we have a president who is mandating that virtually all employers – including religious groups such as Priests for Life and Little Sisters of the Poor -- provide their employees with insurance for contraceptives, sterilization, and abortion-inducing drugs.

If this country and its people are to halt the rush into national licen-tiousness and return to a morals-based culture, there must be a recogni-tion throughout society that God exists, that He set forth Command-ments on how we should live our lives, that marriage has a procreative purpose, that human life must be respected and protected from concep-tion to natural death, and that we will be judged by Him to account for how we live our lives. This re-evangelization must begin with Catho-lics through the Church, from the pulpit. It can be accomplished, but only with God's help through prayer. Let it begin with us – and now.
