CHAPLAIN'S CORNER

From State Chaplain Reverend Milton E. Jordan's column in the November 2014 Maryland State Council newsletter.

Hopefully our Councils and Chapters have undertaken at least some style of *Building the Domestic Church: The Family Fully Alive*. It is the program strongly recommended by Supreme Knight Carl Anderson.

The purpose of this program is to help individual Knights build a strong sense of prayer and fidelity to families as we prepare for the 2015 Fall International Congress for Families event that will occur in Philadelphia in September next. The family should be a model of the Church itself in our homes. Prayer, discussion and perhaps several trips to special churches, shrines or places should be fortified in our homes during the next twelve months and thereafter.

As Knights, we have a remarkable treasure house of information and graces in all of the feasts our Church celebrates each year. Recently, Cardinal Donald Wuerl published a book titled *The Feasts – How the Church Year Forms Us as Catholics*. The authors of this book as well as Matthew Kelly in his newest publication *Rediscover Catholicism* point out: we are a religion for which feasts are very important. Both publications note that it is our feasts that we celebrate which define us. Even in our Knights of Columbus world it is feasts and calendars that are very important to us. They help us strengthen our fraternal bonds as well as our personal relationship with God and the saints. Likewise our Church uses feasts as instruments to draw us ever closer to Jesus Christ and his Eucharistic feast, the sacred liturgy of the Mass. The Roman Calendar and the various feasts honor God, members of the Holy Trinity, Saints, and our Church that help us in our efforts to strengthen what it means to be a Roman Catholic. This is hardly different from the KofC annual calendar which helps us strengthen our understanding of what it means to be a Knight. Our calendars are filled with meetings for Councils/Chapters as well as State Conventions, annual Supreme Conventions – all events that bring us together as Knights to learn what we are to become through the years. These events and many others help define in our minds and hearts what it means to be a follower of Fr. Michael J. McGivney, our Founder.

One might ask: "Why have feasts been so important for our Church and our personal faith?" The answer is quite simple, so simple we may have forgotten the answer. The Church has used these feasts to bring us to a deeper understanding of the Eucharist because usually there is a Mass attached to the feast or celebration. Perhaps this is why the Installation Ceremonies for Officers and other major events include the celebration of Mass. Not to incorporate the Mass in our events is, at least in the mind of this Chaplain, a flaw in the spiritual armor we Knights are expected to possess.

Even in our Catholic communities, parishes or (arch) dioceses and other Catholic organizations, not including the celebration of the Eucharistic Liturgy speaks much about the diminishing practices of Catholicism in our world today. Recently a devout parishioner asked me why we were making the daily Mass on Thanksgiving Day something special. I was stunned that Catholics might not see that Thanksgiving Day as well as Labor Day, the 4th of July, and Veterans Day are feasts we celebrate as a nation in thanksgiving for the significance of the particular feast/holiday we celebrate. Do we as Catholics forget that through the Eucharist we can see the many different ways we are blessed by God, our families and our dedicated armed forces personnel. As we make an effort to rebuild a sense of spirituality within our families through praying together, the rosary or through a short reading of scripture each day, let us not forget the treasury we possess in the saints we celebrate so many days each year as well as the many special feasts that mark significant events in the life of Jesus Christ. Indeed FEASTS are avenues for each of Knights to walk his family – especially as we prepare for the Congress of the Families.

Ultrasound Initiative celebrates five years with 500 machines delivered

The Knights of Columbus has donated an ultrasound machine to a Baltimore pregnancy center, making it the 500th such gift by the Knights to a pregnancy center dedicated to helping women keep and care for their unborn babies. This machine was donated under the Order's Ultrasound Initiative.

"We have reached a significant milestone in this effort, which has been a great success because it has allowed countless women to recognize the miracle of the new life within them," said Supreme Knight Carl Anderson before presenting the ultrasound machine to the Greater Baltimore Center for Pregnancy Concerns, Inc. "In the vast majority of cases, this experience allows the women to decide in favor of keeping their babies."

Supreme Knight Anderson made the presentation along with Supreme Chaplain and Archbishop of Baltimore William Lori at an annual mid-meeting of state deputies held in Baltimore.

The Knights Ultrasound Initiative began in January 2009 and initially provided a dozen or so machines that produced images of the unborn. The program has since expanded to all 50 U.S. states, Canada and Jamaica, and employs a range of devices, including the latest three-dimensional technology that allows the mother to see detailed images of her child in real time.

From the beginning, the availability of ultrasound technology has had a powerful impact, as it enriches the bond between mother and child — and father and child — and informs their decision-making about abortion.

The program encourages local Knights councils to advocate for qualified pro-life centers in their areas by raising half the expense of an ultrasound machine through a variety of fund-raising efforts. The K of C Supreme Council's Culture of Life Fund then matches those dollars to contribute to the purchase of a single machine.

The initiative continues to expand and, in recent years, there has been increase in mobile medical units that serve a number of communities by using ultrasound machines the size of a laptop computer.

We have contracted some major repair to the Council Home. During the punishing cold weather last winter, we were experiencing very high propane bills even though many days we were just keeping the hall warm enough to prevent freezing. One of the reasons for this is that the door frames around both the side and the kitchen doors are so deteriorated that heat escapes under them. We requested an assessment from Brother Bill Ensor whose company is experienced in this kind of work and presented us with a proposal to repair the frames and replace the molding and sills as well as install a drip strip to divert water away from the doors. We can repair the kitchen door, however the entrance door has been repaired so many times it will need to be replaced. In addition, the kitchen window is so rotten it needs to be replaced. This total job will be performed by Bill's company, Beeco, Inc and will begin in the near future. Hopefully, we will be better prepared for cold weather this year than we have been in the past and we will recover some of this expense through lower energy costs.

dents in general. Below is a brief summary of these scholarships and information regarding eligibility for scholarship awards.

The Frederick M. Gossman Memorial High School Scholarship

Designed to assist those Brother Knights holding membership in councils within the jurisdiction of Maryland in paying tuition for their sons and daughters at accredited -Catholic High Schools; three grants of \$1,500.00 per year, for up to four years, will be awarded. Awards will be made on the basis of academic excellence, personal qualifications, and financial need. The children of deceased members are also eligible, provided the member was in good standing at the time of death.

The William J. O'Brien Jr., Memorial Catholic High School Scholarship

Three grants of \$1,500.00 per year for up to four years will be awarded. This program is open to any Catholic student who is a resident of the State of Maryland to include children and grandchildren of a member of a Knights of Columbus council within the jurisdiction of Maryland. Applicants must have been officially accepted at or must be students at accredited Catholic High Schools. Applications will be judged on academic excellence, personal qualifications, and financial need.

Application period is from October 1,2014 to February 1,2015. All applications must be received by the Scholarship Committee no later than February 1, 2015.

SUPREME COUNCIL SCHOLARSHIPS

Three College Scholarships are available for undergraduate studies for students entering the freshman year in a program leading to a Bachelor's Degree. The scholarships are awarded for one year and are renewable for each year of undergraduate study to a total of four years subject to evidence of satisfactory academic performance and the discretion of the committee on Scholarships.

The scholarships are competitive and are awarded on the basis of academic excellence. Selection is made after a review of the secondary school record, class rank and the results of aptitude test scores. To be considered eligible, an applicant must be a member in good standing of the Knights of Columbus; the son or daughter of such a member, or of a deceased member who was in good standing at the time of his death; or a member of the Columbian Squires.

The scholarship grant is \$1,500.00 per year for the three scholarships. Also a requirement is that you must attend a Catholic College or University.
