Dear Brother Knights,

The blessed season is upon us!



In the mind of most Catholics I think that Advent and Christmas are thought of as two separate seasons of the year. One is before the Christmas feast and the other after. In my own mind and heart they are not two seasons but one. Advent is time spent with a focus on the coming Christ; Christmas itself is time spent rejoicing that Christ once came; the Christmas season is time spent living out the consequences of the Incarnation. This is all one grand event that has the mystery of God-become-man at its center.

Most of us have routines that we gladly keep during these days of the Advent-Christmas season. We pray. We go to the sacrament of Reconciliation before Christmas. We shop, bake and decorate. We plan which social gatherings to attend or host. It is all wonderful, but it is all so expected! Every year we tend to do the same things, and in keeping a routine holiday we lose the sense of wonder and awe at what God has done. That is why I am encouraging you to look at the Advent-Christmas season as a single event. When the Christmas feast itself is past embrace the whole season of the Incarnation! The Christmas season lasts from Dec. 25<sup>th</sup> to Jan. 9<sup>th</sup> this year. It includes a series of great feast days and is meant to be a time of actively living out the truth of God-with-us. The actual Incarnation is anything but an expected event! Who could ever have imagined that God the Almighty would become human? If you accept this truth, then spend the entire Christmas season by acting on the implications of God who has come among us.

How do you do that? Every one can think of his own response. At St. John parish we are going to distribute a "12 Days of Christmas" program for home use. It will be full of ideas for each of the 12 days of the season. We are also going to encourage participation in a Magi Project. The three Magi brought gifts to the Christ child; we will be asking parishioners to respond to God's gift of Himself to us by making a gift of food to the poor. What better way could there be to acknowledge the truth of what we celebrate at this season?

If you pray even a little about keeping the entire Christmas season, you will be able to see how important it is that you should make a response to what we celebrate, the mystery of God-among-us. And I am sure you will devise an appropriate activity for you and for your family that will make Christmas live well beyond Dec. 25<sup>th</sup>.

It is a celebration that children and adults can enjoy together, as well as those from all different cultural backgrounds.

Even if you are not familiar with the Christmas Posada, the Knights of Columbus invites you to join this ancient observance that will open for you the deeper meaning of a joyful season. To help you understand the tradition, the Order offers the booklet The Posada: An Advent & Christmas Celebration (#9898-E,S,F).

Through distribution of this booklet, the Order hopes to bring the rich Posada tradition to all Knights and their families as a way of encouraging a sharing of cultures in the Americas around the celebration of the birth of our Savior. This booklet provides all that is needed to conduct a Christmas Posada with your family and your Knights of Columbus council. #### "I Already have Insurance at Work"

Many jobs offer some form of group term life insurance. Often, this insurance is an employee benefit provided at no charge, or for a small co-pay.
